WILL YOU BE MY GUARDIAN AD LITEM?

CAN YOU HELP?

Yes, you can become a Guardian ad Litem volunteer! This year in Cumberland County, an increasing number of children will need someone to give them a voice and see that their best interests are served. Because the number of cases has grown tremendously in recent years, **more volunteers are urgently needed.**



A Guardian ad Litem volunteer is appointed by the juvenile court and is paired with an attorney to investigate the case, to make recommendations regarding a safe, permanent home, and to advocate for special services.

A Guardian ad Litem volunteer also prepares written reports that are submitted to the juvenile court judge for review. These reports outline facts of the case and recommendations on what is in the best interest of children. The reports also include, from their perspective, the wishes of the children about their needs and where they want to live.

GETTING STARTED!

There are some things you have to do before you become a Guardian ad Litem:

- Complete an application which includes providing 3 personal references and submitting to criminal background checks. You can obtain an application at www.ncgal.org
- Complete a personal interview
- Complete 30 hours of group or individual training including 4 hours of court observation
